# **ADMISSION**

## of NON-EU Applicants for Master's Degree

#### **APPLICATION DOCUMENTS:**

- 1. Application form;
- **2. Secondary School Diploma and Diploma Supplement** (certified copy by notary public); \*In case there is no grading scale attached to the diploma, candidates have to present an official document with the grading system description.
- 3. An official document issued by an accredited body, certifying the applicant's right to pursue their studies at higher education institutions in the country where secondary education was obtained (Download form: <a href="here">here</a>);
- 4. Higher Educational Diploma with a degree corresponding to the Bachelor's or Master's Degree as well as Diploma Supplement (certified copy by notary public);
- \*In case that the Diploma was issued from Foreign Higher Education Institution the applicants must present a Certificate of recognition of Higher Educational Degree, issued from TU-Varna.

### 5. Medical Reference;

\*The document should be issued no earlier than one month prior to submitting the application documents to TU-Varna.

## 6. Copy of passport/ID card;

\*Documents specified in points 2, 3 and 4 must be certified, legalized and translated in accordance with the International Agreements between Republic of Bulgaria and the country in which they are issued; in case of lack of these documents – by the common order of the legalizations, translations and validations of the documents and the other papers.

## **ADMISSIONS CRITERIA:**

The applicants must obtain Academic Grade Average from Secondary School Diploma (Academic Grade Average from the Grade Average of the course subjects included into the Course Content and Grade Average of the State Examinations or of the Diploma Thesis) **not less than the Grade "Good".** 

#### **ADMISSIONS PROCESS:**

The applicants must send the scanned copies of their documents to the Foreign Students Department of TU-Varna at the following email address for a preliminary look: <a href="mailto:fs centre@tu-varna.bg">fs centre@tu-varna.bg</a> The candidates have to scan all the pages of the required documents, including the stamps.

After approval of the provided documents from the Foreign Student's Department, the applicants must:

➤ to pay the fee in amount of 150 lv. into the Bank Account of TU-Varna for the recognition of Higher Educational Diploma from Foreign Higher Education Institutions and to complete an **Application** for starting the procedure;

### The deadline for the submission of documents: 30.09

Foreign Students Department sends to the Ministry of Education and Science the document of the approved applicants, according to the art. 95, par.8 of Higher Education Act in order to complete the procedure of Issuing the Visa for Long-Term Residence (**type D**).

After receiving the certificate from Ministry of Education, the applicants must submit their documents to the Embassy/ Consulate of Republic of Bulgaria in order to receive Issuing of the Visa (type D).

After obtaining the Visa the applicants can be enrolled at the University.

### **CERTIFYING A BULGARIAN / ENGLISH LANGUAGE LEVEL:**

The applicants who present some of the listed documents do not have to undertake a Preparatory Language Course and they are directly submitted in the first (or higher) year of studying. For Bulgarian Taught Preparatory Course the final exams for the specialized disciplines must be undertaken until the end of the first year of studying.
